- As a Company, we provide a working environment based on diversity and inclusivity principles, adopting universal human rights in our relations with all stakeholders, without discrimination based on language, belief, race, age, gender, sect, political thought, disability, social class, marital status, nationality, skin color, sexual orientation, philosophical belief, participation in union activities, pregnancy, military service, or similar distinctions. We protect employee rights, work to prevent child labor and modern slavery, and respect the rights to unionization and collective bargaining.

- We carefully implement our Occupational Health and Safety Policy and measures, and regularly review them.
